- A. GACA shall continue to uphold very high standards of service and witness and will always refer to the Bible as ‘The Final Authority’.**
- B. Candidates for membership of GACA must be in agreement with the criteria set forth which must be adhered to in order to enjoy a healthy and prosperous relationship as GACA members.**
- C. The members must be responsible and accountable; willing to abide in the rules and regulations of GACA.**
- D. However, GACA will not interfere in the way that the members’ Churches function.**
- E. Members must represent a recognised congregational Church or Ministry (individual membership is not applicable)**
- F. Members must be financially committed to paying an Annual Subscription Fee.**
- G. To demonstrate unity and commitment, members may be asked to attend meetings, leadership development seminars and at least two conferences per year.**
- H. A senior representative of GACA will visit the members (Churches) from time to time to establish their existence and to get to know them better.**
- I. Churches will be subject to an initial assessment before approval of membership.**
- J. GACA shall exercise the disciplinary policy; the Association reserves the right to exclude member Churches or refuse applicants’ entry into GACA.**
- K. All GACA decisions are subject to approval by the Executive Committee.**
- L. All Ministers are expected to uphold ecclesiastical protocol without exception.**
